## PERSONAL APOSTILLE RATES

### 1ST PERSONAL APOSTILLE

Standard processing for 1 apostille.

- Includes FedEx delivery within the U.S.

### 2ND OR MORE PERSONAL APOSTILLES SAME STATE

Example 1: 2 birth certificates and 2 marriage certificates from the same state:  $\$175 + \$130 + \$130 + \$130 = \$565$

- Example 2: 2 birth certificates from one state and 2 marriage certificates from another state:  $\$175 + \$130 + \$175 + \$130 = \$610$

- **\*Timeline: Within 10 business days or sooner\***

### RUSH PROCESSING SERVICES FOR PERSONAL APOSTILLES

Example 1: 1 birth certificate and 1 marriage certificate with rush processing:  $\$175 + \$175$  (rush) +  $\$130 + \$175$  (rush) =  $\$655$

- Example 2: 1 birth certificate from one state and 1 marriage certificate from another state:  $\$175 + \$175$  (rush) +  $\$175 + \$175$  (rush) =  $\$700$

- **\*Timeline: Within 5 business days or sooner\***

### 2ND OR MORE BUSINESS APOSTILLES SAME STATE

- Example 1: 2 articles of incorporation and 2 bylaws from the same state:  $\$220 + \$140 + \$140 + \$140 = \$640$

- Example 2: 2 articles of incorporation from one state and 2 bylaws from another state:  $\$220 + \$140 + \$220 + \$140 = \$720$

- **\*Timeline: Within 10 business days or sooner\***

### RUSH PROCESSING SERVICES FOR BUSINESS APOSTILLES

- Example 1: 1 article of incorporation and 1 bylaw from the same state with rush processing:  $\$220 + \$200$  (rush) +  $\$140 + \$200$  (rush) =  $\$760$

- Example 2: 1 article of incorporation from one state and 1 bylaw from another state:  $\$220 + \$200$  (rush) +  $\$220 + \$200$  (rush) =  $\$840$
